- 2. Indicate the Cost/Time Savings listed in item 1 by:
  - a. Providing the percentage of cost and/or time savings and explain how you arrived at these numbers
  - b. Explaining the cost and/or time savings realized within other departments of your company due to the Payroll Best Practice
- 3. Indicate how Payroll Best Practice(s) listed in item 1 were:
  - Identified as best practices for your company or industry (e.g., APA Payroll Congress, APA's Implementing Payroll Best Practices, Payroll Benchmarking Study, Payroll Leaders Conference)
  - b. Presented to management for buy-in
  - c. Introduced to your employees and implemented
